To qualify for OBRP, air conditioning equipment must be paired with natural gas water heating or heating installation.

Maximum combined HVAC and water heating equipment at 0% APR financing is \$14,000.

Note there is a financing cap on each piece of equipment (see above). All loans are net NJCEP rebates.

NJCEP \$200 bonus incentive is available for homes located in an Urban Enterprise Zone (UEZ).*

NJNG reserves the right, with approval of the State of New Jersey Board of Public Utilities, to terminate, modify, suspend or extend this rebate program. NJNG rebates and incentives do not apply to new construction. Offer applies to equipment purchased and installed by December 31, 2021. Rebate applications must be postmarked within 180 days of equipment purchase date. Customer must submit a paid receipt and proof of permit with NJNG application.
